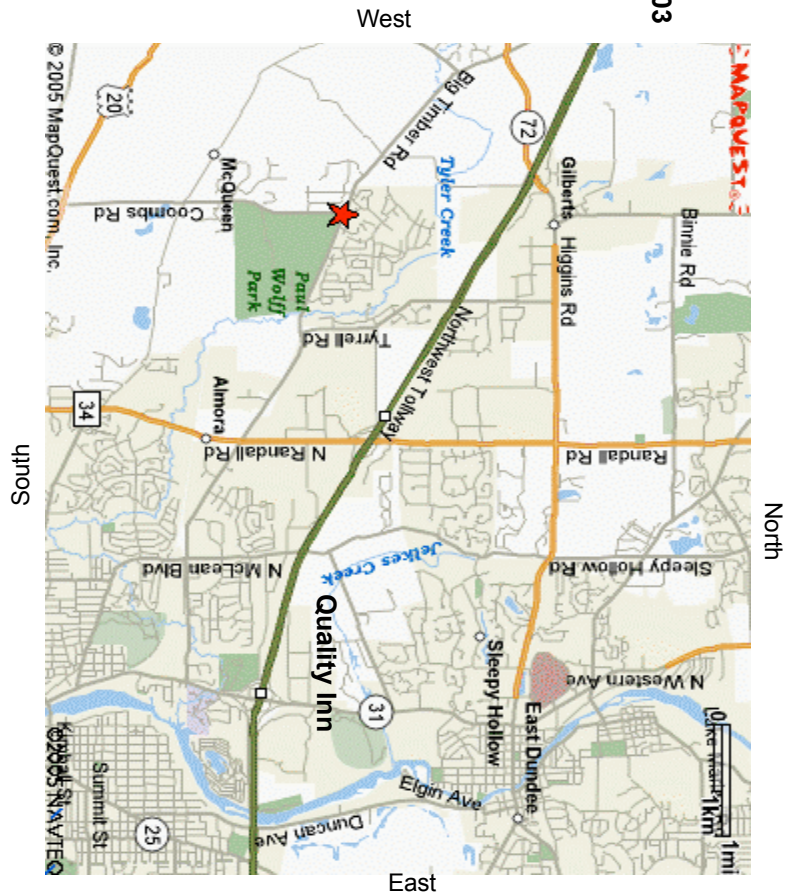

Entries will not be accepted without proper fees and signature(s) and must be on an approved AKC entry form with the agreement printed on the reverse side. In accordance with the AKC Obedience Regulations, Chapter 1, Section 26a, Entries in this tracking test shall be accepted until the official closing date even though the advertised limit has been reached.

The drawing for this test shall take place on Monday, August 23, 2010. Entries will be drawn at 7:00 PM CT . At that time it will be determined which of the entries will participate in this event. The drawing will be at random among all entries, but preference will be given to dogs which have not earned a TDX title. When the limit has been drawn, all remaining entries shall be drawn in the same manner as above and assigned a position on the alternate list.

ALL ENTRIES WILL BE NOTIFIED BY EMAIL WITHIN THE FIRST 24 HOURS OF THE DRAWING.

ONLY THOSE (5) ENTRIES DRAWN FOR THE TEST WILL BE NOTIFIED BY PHONE ON MONDAY EVENING 8/23/10 AFTER THE DRAW.

Entry fees will not be refunded for any reason except for: bitches who come into season after the closing date, alternates who do not run, and any entrants who are replaced by an alternate at the test.

Entry fees will be refunded with seven (7) days following the date of the test. In the event an accepted entry cancels prior to the test date, the Test Secretary shall contact alternates according to their placement on the alternate list and upon notification, said alternated shall have the option of accepting or refusing the opportunity to participate in the test. In the event an accepted entry is absent the day of the test, it shall be the responsibility of the Test Secretary to determine if alternates are present and based on their position on the alternate list, determine which shall participate.

It shall be the responsibility of the Judges to assign dogs to the tracks by the drawing of lots.

Note: Bitches in season will **NOT** be allowed to run.

Each dog passing this TDX Test will receive a plaque OR ornament and green rosette.
